CIRCULAR

The Bihar Human Rights Commission (BHRC) has resolved to organize one-day capsule courses for creating awareness and sensitization and developing a positive and humanitarian outlook towards human rights across the State among college and university students as well as faculty members of the various under-graduate and post graduate classes.

(2) The BHRC, hereby, forms a committee for the systematic organization of these capsule courses throughout the State.

The Committee will consist of

- (a) The Secretary, BHRC
- (b) Principal, Patna Law College, Patna University, Patna
- (c) Director, Higher Education, Govt. of Bihar, Patna

The Secretary, BHRC, will function as the ex-officio head of the Committee. The SP, BHRC would be associated with this Committee as a permanent invitee.

(3) Tasks

- (a) The Committee will keep a databank of students trained under this Programme. In future, these students will act as resource persons.
- (b) The Committee will take assistance from eminent human rights activists, jurists, serving and retired civil and police officers, political scientists and others to deliver lectures and other academic activities at these capsule courses.
- (c) The Committee will meet on the 6th of every month at 04:00 PM in the Secretary, BHRC office to review past courses and prepare future courses. if the 6th day of a month happens to be a holiday the meeting will take place in the next working day at 4 p.m.

- (d) The Committee will regularly brief the media (print and electronic) about capsule and other courses offered in order to create a friendly environment for the purpose of spreading human rights literacy.
- (e) Beginning with Patna, all 38 districts of the State will be covered, preferably in next two years.
- (f) Depending upon the availability of funds, the Committee will get human rights literature published in English and Hindi to be distributed among students attending capsule courses.
- (g) In addition to above tasks, the Committee will take all other relevant measures necessary for expanding and deepening of awareness/sensitization towards human rights among the youth and other sections of the society.
